3. ADOPTION TERMS AND CONDITIONS

- 1. Transfer of Custody.** Upon execution of this Agreement and payment of the adoption fee, custody of the cat transfers to the Adopter, subject to all terms contained in this Agreement.
- 2. Standard of Care.** The Adopter agrees to provide appropriate food, clean water, safe indoor shelter, humane treatment, routine veterinary care, emergency veterinary care when reasonably necessary, and all other care appropriate for the cat's health and welfare.
- 3. Veterinary Care After Adoption.** The Adopter understands that veterinary care is an ongoing responsibility of pet ownership. Except for any service expressly stated in writing as remaining the responsibility of The Purrfect Pour Cat Cafe, all veterinary examinations, diagnostics, medications, treatments, emergency care, vaccinations, boosters, and other medical expenses incurred after adoption are the Adopter's responsibility.
- 4. No Health Guarantee.** The Purrfect Pour Cat Cafe provides available health and veterinary information in good faith but makes no guarantee regarding the cat's future health, temperament, behavior, genetic condition, or freedom from latent, incubating, congenital, infectious, or other conditions that may become apparent after adoption.
- 5. Existing Records.** The Adopter acknowledges receipt of the veterinary and/or health records made available for the cat and understands that age and medical history may be estimated when complete prior history is unavailable.

4. HEALTH RESPONSIBILITY AFTER ADOPTION

IMPORTANT HEALTH ACKNOWLEDGMENT: The adopter acknowledges that The Purrfect Pour Cat Cafe has provided care for the cat prior to adoption but cannot guarantee the future health, temperament, or medical condition of the animal. Any illness, injury, behavioral concern, congenital condition, or other health-related issue that arises after the cat leaves The Purrfect Pour Cat Cafe shall be the responsibility of the adopter. The adopter agrees that veterinary expenses, treatments, medications, diagnostics, and ongoing care required after adoption are the responsibility of the adopter, except where The Purrfect Pour Cat Cafe has expressly agreed otherwise in writing.

5. VACCINATIONS AND PREVENTIVE CARE

6. Vaccination Records. The Adopter acknowledges that the vaccination and preventive-care history provided at adoption reflects the information and records available to The Purrfect Pour Cat Cafe. The Adopter is responsible for discussing future vaccination schedules, boosters, testing, parasite prevention, and other preventive care with the Adopter's veterinarian.

7. Veterinary Recommendations. Veterinary recommendations may differ based on age, health status, prior history, risk factors, and the veterinarian's professional judgment. Any decision to repeat, delay, or administer additional vaccines or treatments after adoption is between the Adopter and the Adopter's veterinarian and is the Adopter's financial responsibility.

6. SPAY / NEUTER REQUIREMENT

8. Already Altered. If the cat has already been spayed or neutered, available documentation will be provided with the adoption records.

9. Pending Procedure. If the cat is adopted before spay/neuter is completed, the responsible party and expected completion date shall be documented below. If the Adopter assumes responsibility for the procedure, proof of completion must be provided by the agreed-upon date.

10. Failure to Provide Documentation. If the Adopter has agreed to complete the spay/neuter procedure and fails to provide documentation by the agreed-upon date, The Purrfect Pour Cat Cafe may request the return of the cat in accordance with this Agreement and any applicable law.

7. HUMANE CARE AND DECLAWING

11. No Declawing. The Adopter agrees not to have the cat declawed. Medically necessary procedures recommended by a licensed veterinarian for treatment of disease, trauma, or another legitimate medical condition are not considered elective declawing under this provision.

12. No Abandonment. The cat shall not be abandoned, intentionally released outdoors, surrendered to an unknown third party, sold for research, used for breeding, or subjected to neglect or abuse.

8. RETURN AND REHOMING

13. Return to The Purrfect Pour. If the Adopter can no longer keep the cat, the Adopter agrees to contact The Purrfect Pour Cat Cafe before transferring ownership or surrendering the cat elsewhere. Return arrangements are subject to coordination so that safe placement and available space can be addressed.

14. Refunds. Unless separately agreed to in writing, adoption fees are non-refundable. A voluntary decision by The Purrfect Pour Cat Cafe to refund an adoption fee in a particular circumstance does not create an obligation to refund fees in other adoptions.

15. Bonded Pairs. If this adoption is designated as a bonded-pair adoption, the Adopter agrees that the bonded cats are to remain together unless separation is medically necessary or The Purrfect Pour Cat Cafe provides written approval.

9. OTHER ANIMALS AND HOUSEHOLD RESPONSIBILITY

16. Introductions and Quarantine. The Adopter is responsible for safe introductions, appropriate separation or quarantine when recommended, and veterinary guidance regarding exposure of the adopted cat to other household animals.

17. Household Veterinary Expenses. The Purrfect Pour Cat Cafe is not responsible for veterinary expenses incurred for other animals in the Adopter's household after adoption unless expressly agreed to in a separate written agreement.

10. REPRESENTATIONS AND ACKNOWLEDGMENTS

18. Information Provided by Adopter. The Adopter represents that the information provided in the adoption application and during the adoption process is truthful and complete to the best of the Adopter's knowledge.

19. No Guarantee of Behavior. The Adopter understands that behavior may change in a new environment and that The Purrfect Pour Cat Cafe cannot guarantee compatibility with people, children, other animals, housing conditions, or future circumstances.

20. Opportunity to Ask Questions. The Adopter acknowledges having had an opportunity to ask questions regarding the cat's known history, care, health records, adoption terms, and any pending obligations before signing.

21. Entire Agreement. This document, together with any specifically incorporated written addendum or cat-specific record signed by both parties, constitutes the parties' written adoption agreement. Changes should be made in writing and acknowledged by both parties.

22. Severability. If any provision of this Agreement is determined to be invalid or unenforceable, the remaining provisions are intended to remain in effect to the extent permitted by applicable law.
